### STEP-3: SUCCESSFUL LOGIN-IN SCREEN

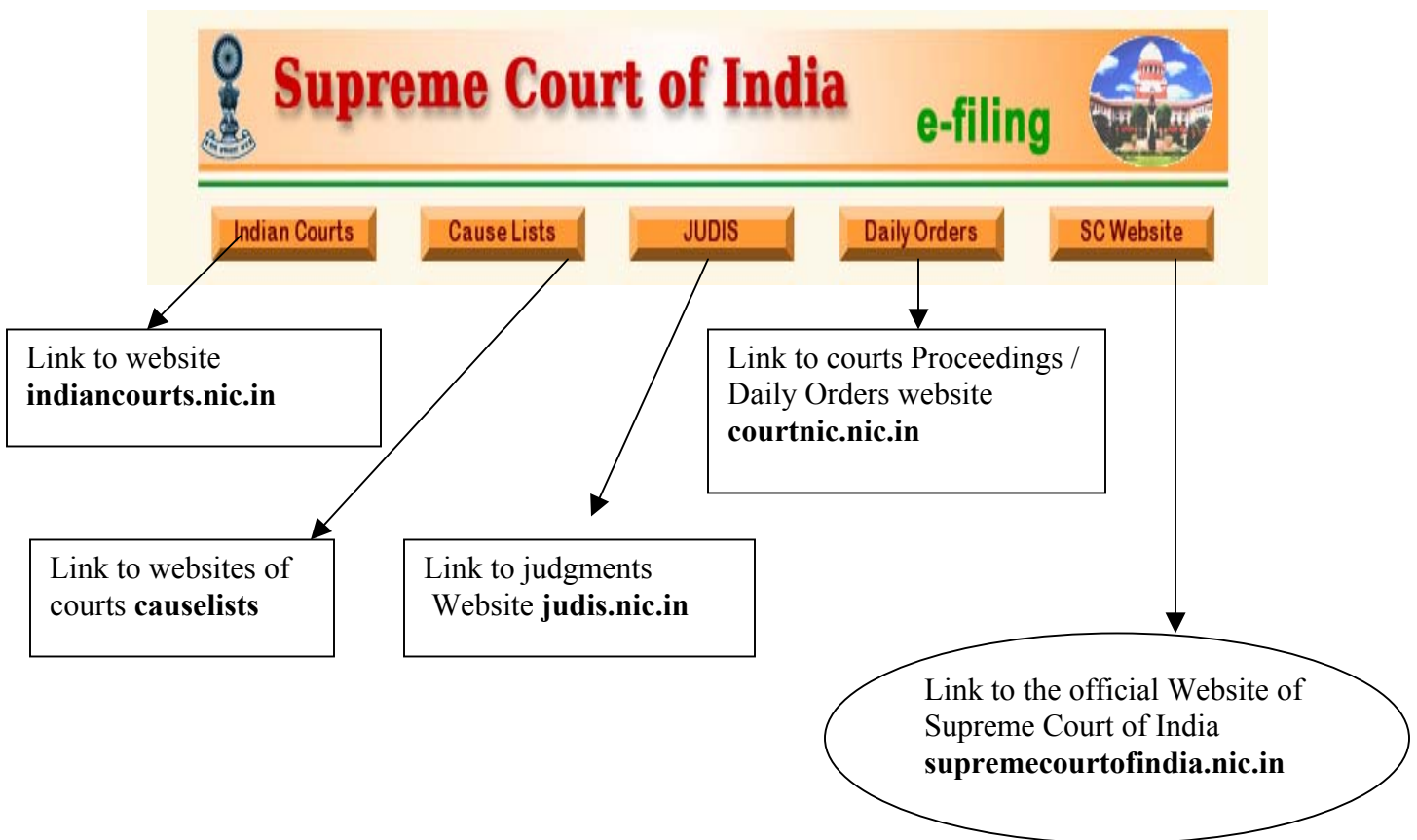

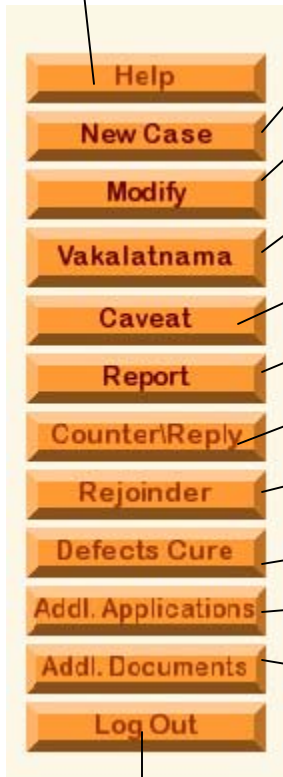
